ARTICLE III - DURATION

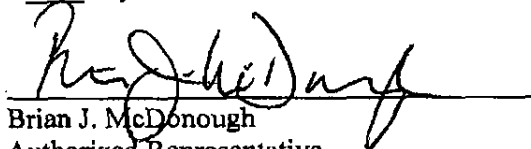

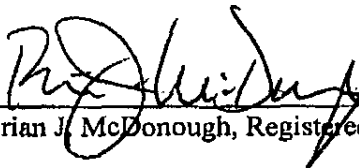
