**ARTICLES OF ORGANIZATION
OF
M&M PALM BEACH GARDENS, LLC**

The undersigned authorized representative hereby executes these Articles of Organization ("Articles") for the purpose of forming a limited liability company in accordance with the laws of the State of Florida.

ARTICLE I

Name

The name of this limited liability company (the "Company") shall be:

M&M PALM BEACH GARDENS, LLC

ARTICLE II

Principal Office and Mailing Address

The mailing address and the street address of the principal office of the Company shall be:

ARTICLE III

Registered Office and Registered Agent

The initial registered office of the Company shall be located at 1200 South Pine Island Road, Plantation, Florida 33324, and the initial registered agent of the Company at such office shall be C T Corporation System. The Company shall have the right to change such registered office and such registered agent from time to time, as provided by law.

ARTICLE IV

Operating Agreement

The power to adopt the Operating Agreement of the Company, to alter, amend or repeal the Operating Agreement of the Company, or to adopt a new Operating Agreement, shall be vested in the members of the Company.

ARTICLE V

Management of Business

Management of the Company shall be vested in its members. Accordingly, the Company shall be a member-managed company.

Amendment of Articles of Organization

The Company reserves the right to amend, alter, change or repeal any provisions contained in these Articles of Organization in the manner now or hereafter prescribed by statute, and all rights conferred upon the members herein are subject to this reservation.
