# **ARTICLES OF ORGANIZATION**

OF

# SMITH FAMILY HONEY COMPANY, L.L.C.

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes, Chapter 608, hereby makes, acknowledges and files the following Articles of Organization.

# ARTICLE I - NAME

The name of the limited liability company shall be SMITH FAMILY HONEY COMPANY, E.L.C. (hereinafter referred to as the "Company").

## ARTICLE II - ADDRESS

The mailing address and street address of the principal office of the Company shall be 12225 91<sup>st</sup> Street, Fellsmere. Florida 32948.

# ARTICLE III - PURPOSE FOR ORGANIZATION

The purpose for which the Company is organized is: Beekeeping, and any other lawful business.

# ARTICLE IV - DURATION

The Company shall commence its existence on the date these Articles of Organization are filed by the Florida Department of State. The Company's existence shall be perpetual unless the Company is earlier dissolved as provided in these Articles of Organization.

# ARTICLE V - REGISTERED OFFICE AND AGENT

The name and street address of the registered agent of the Company in the State of Florida shall be Charles E. Smith, Jr., at 12225 91<sup>st</sup> Street, Fellsmere, Florida 32948.

# ARTICLE VI - CAPITAL CONTRIBUTIONS

The members of the Company shall initially contribute to the capital of the Company in such amounts as agreed to by the members. Each member shall make additional capital contributions to the Company only on the unanimous consent of all the members.

## ARTICLE VII - PROFITS AND LOSSES

(a) SHARING OF PROFITS. The members shall be entitled to the net profits arising from the limited liability company business that remain after payment of the expenses of conducting the business of the limited liability company. # ARTICLE VIII -- ADMISSION OF NEW MEMBERS

No additional members shall be admitted to the Company except with the unanimous written consent of all the members of the Company and on such terms and conditions as shall be determined by all of the members. A member may transfer his or her interest in the Company as set forth in Chapter 608 of the Florida Statutes or the operating agreement of the Company, but the transferee shall have no right to participate in the management of the business and affairs of the Company or become a member unless all of the other members of the Company, other than the member proposing to dispose of his or her interest, approves of the proposed transfer by unanimous written consent.

# ARTICLE IX - TERMINATION OF EXISTENCE

The Company shall be dissolved on the death, bankruptcy or dissolution of a member, or on the occurrence of any other event that terminates the continued membership of a member in the Company, unless the business of the Company is continued by the consent of all of the remaining members.

# ARTICLE X - MANAGEMENT

The Company shall be managed by the members in accordance with the operating agreement adopted by the members for the management of the business and affairs of the Company. The initial member-manager of the Company shall be Charles E. Smith, Jr. The operating agreement adopted by
