3. **Registered Agent and Office.** The name and street address of the initial registered agent and office for the company is as follows:

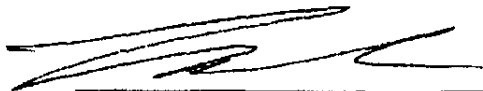
