**ARTICLES OF ORGANIZATION**  
**of**

The undersigned, being a duly authorized person, desiring to form a limited liability company under and pursuant to the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, does hereby adopt the following Articles of Organization:

**ARTICLE I**  
**DURATION**

OCEAN PROPERTIES OF HILLSBORO, L.L.C. shall exist perpetually or until dissolved in a manner provided by law, or as provided in the Articles of Organization adopted by the members.

**ARTICLE II**  
**NAME AND PRINCIPAL PLACE OF BUSINESS**

The name of the limited liability company shall be OCEAN PROPERTIES OF HILLSBORO, L.L.C., and its principal and mailing office shall be located at SUITE 100, 798 SOUTH FEDERAL HIGHWAY, BOCA RATON, FLOIRDA 33432, but it shall have the power and authority to establish branch offices at any other place or places as the members may designate.

**INITIAL REGISTERED OFFICE AND REGISTERED AGENT**

The purpose for which the Company is being formed is to engage in any activity or business permitted under the laws of the United States and the State of Florida.




