**ARTICLES OF ORGANIZATION OF

The undersigned, FRED H. FENN, JR., a natural person competent to contract and a member of HAS PROPERTIES, LLC, hereby presents these Articles of Organization as the Articles of Organization of HAS PROPERTIES, LLC, a limited liability company formed under the provisions of Chapter 608, Florida Statutes.

ARTICLE I - NAME

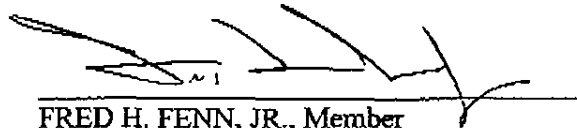
ARTICLE VII - RESTRICTION ON MEMBERSHIP
