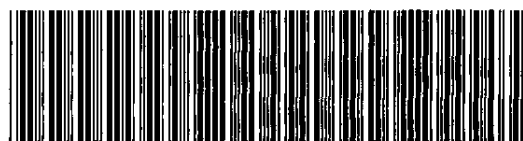



I, the undersigned, hereby make, subscribe, acknowledge, and file, with the Secretary of State of the State of Florida, pursuant to), these Articles of Organization for the purpose of forming a Limited Liability Company in accordance with Chapter 608, Fla. Stat. (2009) and the laws of the State of Florida.

ARTICLE I
NAME

ARTICLE X
ADMISSION OF NEW MEMBERS

Additional members may be admitted from time to time on such terms and conditions as are set forth in the Operating Agreement of this Limited Liability Company.

ARTICLE XI
INDEMNIFICATION

This limited liability company shall indemnify any member, former member, manager or former manager to the full extent permitted by Section 608.4229, Florida Statutes (2009), as amended from time-to-time.

AMENDMENTS
