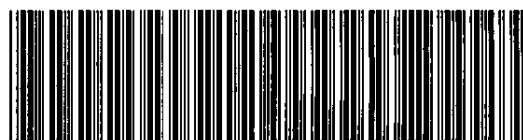

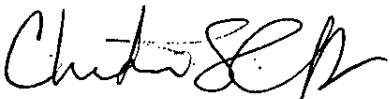

ARTICLES OF ORGANIZATION
OF
TENNISON & SOBERON-LLORT, P.L.

The undersigned, being a duly authorized member, desiring to form a limited liability company under the Professional Service Corporation and Limited Liability Company Act, Chapter 621, Florida Statutes, does hereby adopt the following Articles of Organization:

ARTICLE I- NAME

The name of the limited liability company is Tennison & Soberon-Llort, P.L. (the "Company").

ARTICLE V- CONTINUATION OF LIMITED LIABILITY COMPANY

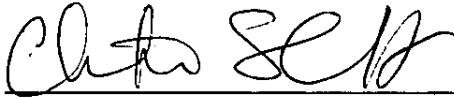

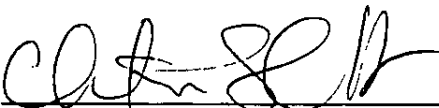
