The name of the Company is SC Advisors, LLC.

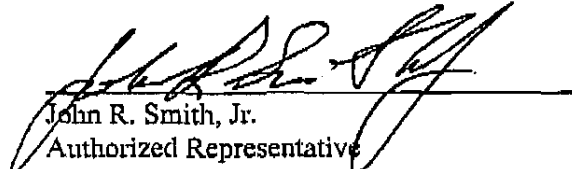
