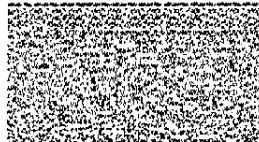

#### **ARTICLE X**




