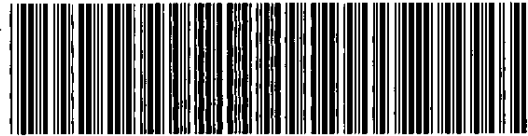



NAME


