**ARTICLES OF ORGANIZATION
OF

The undersigned persons hereby adopt these Articles of Organization in order to form a limited liability company under Chapter 608 of the *Florida Statutes*.

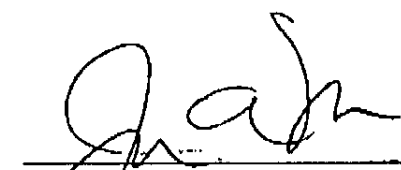

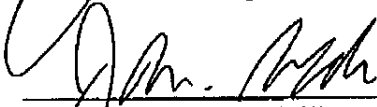

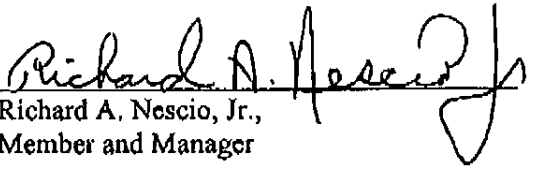
