The name and street address of the initial registered agent of the Company are Lisa D. Van Gilder, 503 Noah Lane, Key West, Florida 33040.

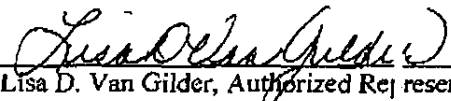
**ARTICLE V. MANAGEMENT**

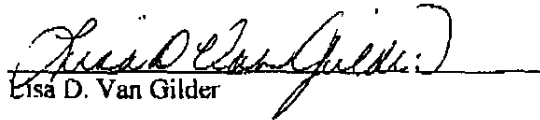
