ARTICLES OF DISSOLUTION OF TYBEE OCEAN VIEW 301 LLC


Pursuant to the provisions of section 608.441, Florida Statutes, this limited liability company adopts the following Articles of Dissolution to its Articles of Organization:

- FIRST:** The name and address of this Company is **TYBEE OCEAN VIEW 301 LLC**, 10675 Pebble Cove Lane, Boca Raton, Florida 33498.
- SECOND:** The date of the adoption of these Articles of Dissolution is 2 December 2011.
- THIRD:** The dissolution of the Limited Liability Company was a unanimous agreement of all members. It is agreed that all debts, obligations and liabilities of the limited liability company have been paid or discharged, or that adequate provision has been made, pursuant to section 608.4421. The remaining property and assets have been distributed among its members in accordance with their respective rights and interests. The amendment was unanimously approved in writing by all members.
