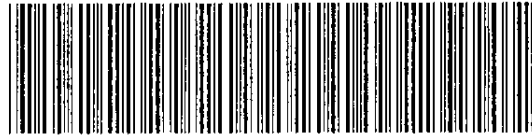

REGISTERED AGENT**


