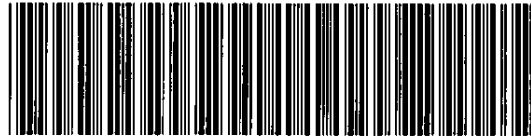

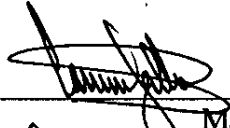
#### ARTICLE VII - TERMINATION OF EXISTENCE

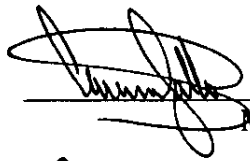
