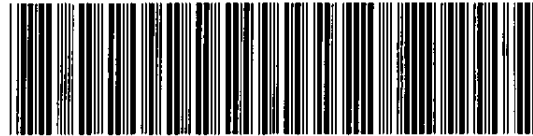

whose mailing addresses shall be the same as the mailing address of the Company.


SECOND: The date of the filing of the Articles of Organization was November 24th, 2010.
