The undersigned, DENNIS P. FOSTER, a natural person competent to contract and a member of FOSTER & COMPANY, LLC, hereby makes, subscribes, acknowledges and files these Articles for the purpose of forming a limited liability company under the laws of the State of Florida.

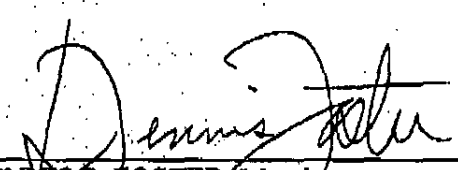
ARTICLE VII (RESTRICTION ON MEMBERSHIP)

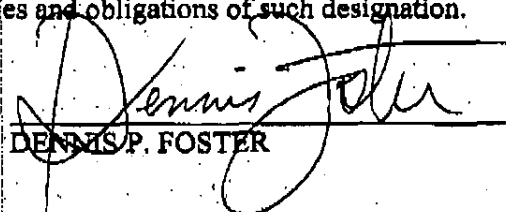
