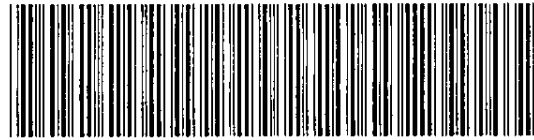

ARTICLE I

NAME
