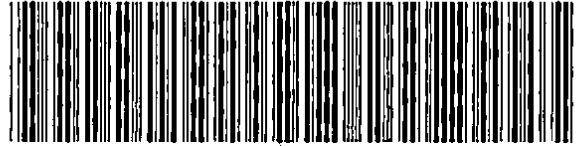

WE HEREBY CERTIFY that the above resolution was adopted and that such resolution is now in full force and effect from this date forward.


