ARTICLES OF ORGANIZATION

OF

COLA GROUP RIVERSIDE, LLC

ARTICLE I

Name of Limited Liability Company

The name of this limited liability company is COLA GROUP RIVERSIDE, LLC (the "Company"), with its principal place of business being located at 8600 8th Avenue, Montreal, Quebec, H1Z 2W4, and the mailing address is the same.

ARTICLE II

Duration

The Company shall exist from the date of filing of these Articles of Organization with the Department of State until the earlier of fifty (50) years from the date of filing or the occurrence of any of the events specified in Florida Statutes Section 608.441, unless continued by the unanimous consent of all of the remaining members.

ARTICLE III

Purpose

The Company is organized for the purpose of transacting all lawful activities and businesses that may be conducted by a limited liability company under the laws of Florida.

ARTICLE IV

Registered Agent and Office

Termination of Membership

Upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member or upon the occurrence of any other event that terminates the continued membership of a member in the Company, the Company shall be dissolved unless the remaining members, by unanimous written agreement, consent to continue the business of the Company.

Management of the Company

If the non-transferring members do not approve the transfer, the transferee of the interest of the transferring members shall have no right to become a member or to participate in the management of the business and the affairs of the Company. The transferee shall be entitled to receive only the share of profits or other compensation by way of income, and the return of contributions to which the transferring member otherwise would be entitled by virtue of membership.

Certificated Interests

The members' interests in the Company shall be evidenced by certificates.
