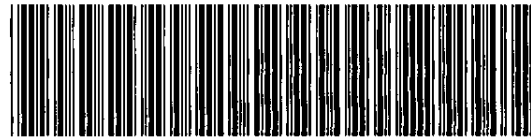


ARTICLE III
