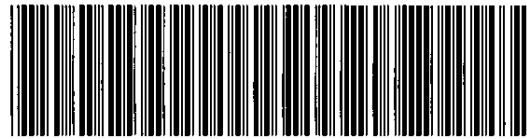

**ARTICLES OF ORGANIZATION
OF
MERRICK WAY LITIGATION ASSOCIATION, PLLC**

ARTICLE I

NAME

The name of this professional limited liability company shall be **Merrick Way Litigation Association, PLLC** and its mailing address and principal place of business is 95 Merrick Way, Coral Gables, Florida 34996 (the "Company").

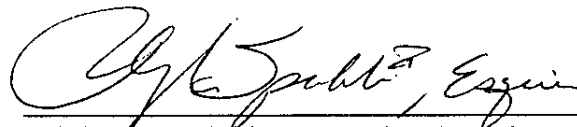

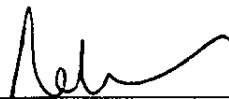
