**ARTICLES OF ORGANIZATION

In compliance with the requirements of F.S. Chapter 608, the undersigned hereby acts as the duly authorized representative of the initial members of a limited liability company adopting and submitting the following articles of organization for the purpose of organizing a limited liability company.

**ARTICLE I**

The name of the Corporation is: Black Bear Ridge Naples, LLC, a Florida limited liability company (the "Company").

**ARTICLE II**

The mailing address and street address of the principal office of the Company is: 2647 Professional Circle, Suite 1201, Naples, Florida 34119.

**ARTICLE III**

The street address of the Company's registered office is: 2647 Professional Circle, Suite 1201, Naples, Florida, 34119. The initial registered agent for the Company at that address is: Chad Kocses.

**ARTICLE IV**

The members of the Company may admit new members to the Company as more fully described in and subject to the terms, conditions and requirements set forth in the Company's Operating Agreement and Regulations. Newly admitted members shall have all the rights and privileges as set forth in the Company's Operating Agreement and Regulations.

**ARTICLE V**

The Company's effective date of existence shall begin on the date of filing these Articles of Organization.

**ARTICLE VI**

The Company's duration shall be perpetual. Upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member, or any other event that would terminate the continued membership of a member in the Company, the remaining members shall have the right to continue the business of the Company as provided in the Operating Agreement and Regulations.

## ARTICLE VII

The initial Operating Agreement and Regulations of the Company shall be adopted by its initial members. The Operating Agreement and Regulations may contain any provision for the regulation and management of the affairs of the Company not inconsistent with the laws or these Articles of Organization.


## ARTICLE VIII
