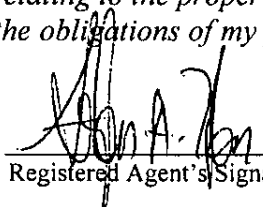
ARTICLE III

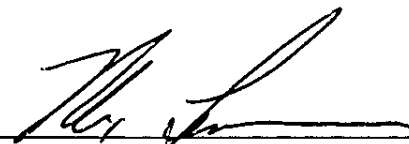
