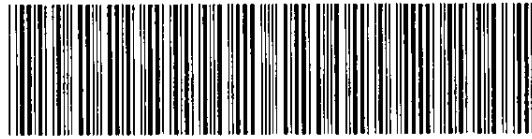

**ARTICLES OF ORGANIZATION FOR  
COORDINATED COMMUNITY SERVICES, LLC**

The undersigned natural person, as an authorized representative of Coordinated Child Care of Pinellas, Inc., the sole member of Coordinated Community Services, LLC, hereby files these Articles of Organization to form a limited liability company under the Florida Limited Liability Act, Chapter 608 Florida Statutes (2002) and any amendments thereto (the "Act").

**ARTICLE I.** **Name:** The name of the limited liability company shall be Coordinated Community Services, LLC (the "Company").

**ARTICLE II.** **Address:** The mailing address and the street address of the principal office of the Company shall be:

10601 Belcher Road South  
Largo, Florida 33777

**ARTICLE III.** **Registered Agent:** The name and street address of the Company's initial Registered Agent for service of process in the State of Florida shall be: Guy M. Cooley, 10601 Belcher Road South, Largo, Florida 33777.

**ARTICLE IV.** **Management:** The Company shall be a member-managed company. The name and address of the sole and Managing Member ("MGRM") of the Company is:

**ARTICLE V.** **Duration:** The period of the Company's duration shall be perpetual from the date of filing of these Articles of Organization with the Secretary of State of the State of Florida, until dissolved in accordance with the Act.

**ARTICLE VI.** **Purpose:** The purpose of the Company shall be to assist its sole member, Coordinated Child Care of Pinellas, Inc., a corporation not for profit formed under the laws of the State of Florida and that is exempted from federal income tax as an organization described by Section 501(c)(3) of the Internal Revenue Code of 1986 (the "Code"), in carrying out the member's charitable purposes. Within the scope of the foregoing, the Company will engage in (a) activities that complement and support the member's principal charitable purpose of enhancing the availability of affordable, accessible, high quality early education and care and other child and family services by providing necessary resources and support services, and (b) similar activities as those conducted by the member, as well as complementary and supporting activities, in geographic areas not previously served by the member, all in a manner consistent with the charitable purposes of the Company's single member.
