ARTICLES OF ORGANIZATION

OF EFFECTIVE DATE 1/1/2011

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE 1 - NAME

The name of the limited liability company shall be **JGS ENTERPRISES, LLC** ("Company").

ARTICLE 2 - ADDRESS

The principal place of business of the Company in Florida shall be 104 Barbara Court, Sebastian, Florida 32958 and the mailing address shall be the same.

ARTICLE 3 - EFFECTIVE DATE

These Articles of Organization shall be effective on January 1, 2011.

ARTICLE 4 - DURATION

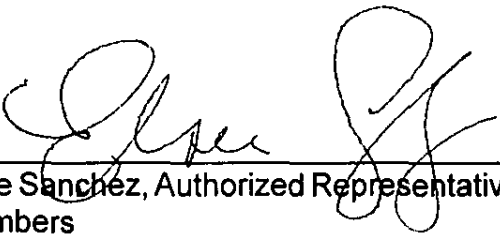

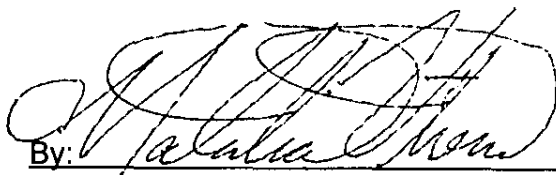
