

Prompt notice of the taking of any action of the members without a meeting by less than unanimous written consent shall be given to those members who did not consent in writing to the action.



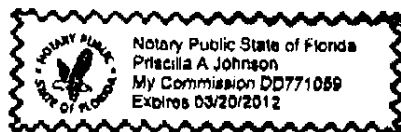
