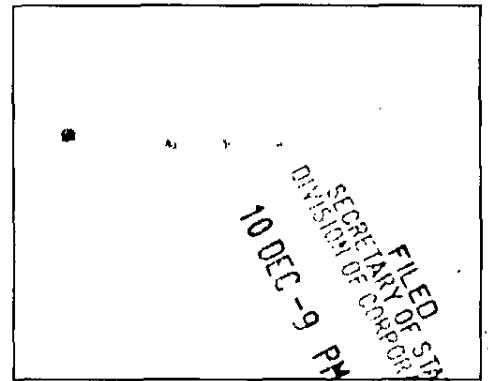

NAME

Except as provided in Florida Statutes, any matter relating to the business of the limited liability company may be exclusively decided by the manager.


ARTICLE V
