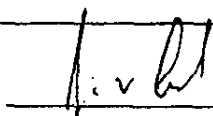

**AGREEMENT ON OWNERSHIP INTEREST  
IN  
QUINCY CYBERCAFE LLC**

**WHEREAS, DEEPIKA PATEL and VIPUL PATEL** have purchased a ninety nine and ninety nine one hundredth (99.99%) percent interest in the Quincy Cybercafe LLC for which they have paid to the present owners consideration of ten (\$10,00) dollars and other good and valuable consideration, and,

**WHEREAS, SURESH PATEL** shall retain a one hundredth (.01%) percent interest in said Limited Liability Company, and

**WHEREAS,** it is contemplated that **DEEPIKA PATEL** shall own seventy nine and ninety nine (79.99%) percent interest in the Quincy Cybercafe LLC, and

**WHEREAS** it is contemplated that **VIPUL PATEL** shall own twenty (20%) percent interest in the Quincy Cybercafe LLC,

**NOW THEREFORE** it is stipulated, contracted and agreed that **DEEPIKA PATEL** is now the owner of seventy nine and ninety nine (79.99%) percent of Quincy Cybercafe, LLC and that **VIPUL PATEL** is now the owner of twenty (20%) percent of Quincy Cybercafe, LLC and that **SURESH PATEL** retains ownership of one hundredth (.01%) percent of Quincy Cybercafe LLC, and it is

**FURTHER** it is stipulated, contracted and agreed by **SURESH PATEL**, that upon the demand in writing of **DEEPIKA PATEL** and by the payment of fifty (\$50.00) dollars, he shall convey to **DEEPIKA PATEL** the one hundred (.01%) interest he has retained in Quincy Cybercafe, LLC.

**FURTHER** it is stipulated, contracted and agreed by **SURESH PATEL**, that upon the

demand in writing of **DEEPIKA PATEL** he shall assign **DEEPIKA PATEL** or his designee that certain Lease Agreement dated December 30, 2010 in which Quincy Square LLC is the landlord and **SURESH PATEL** is the tenant and the leased premises is 1602 & 1600 West Jefferson Street, Quincy, Florida 32351. If for some reason **SURESH PATEL** is unable to obtain the consent of the landlord to assign the lease, then he agrees that the lease shall remain in his name for its duration and he will take all necessary steps to renew the option set forth in paragraph four (4) of the Lease Agreement. Quincy Cybercafe, LLC shall be responsible for the monthly payments of rent and any other terms and conditions set forth in the Lease Agreement

**FURTHER** if any party hereto shall institute any court action concerning this agreement the prevailing party shall be awarded court cost and attorney fees.
