ARTICLES OF ORGANIZATION

In order to form and create a limited liability company pursuant to Chapter 608 and <u>Fla. Stat.</u> \$608.407 of the laws of the State of Florida, I do hereby execute and adopt these Articles of Organization to be filed with the Florida Department of State and do hereby state and certify the following:

ARTICLE I - NAME OF LIMITED LIABILITY COMPANY
