ARTICLES OF ORGANIZATION

OF

INTERNATIONAL GLOBAL SERVICES LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE 1 - NAME

All references in these Articles of Organization to "member", "manager", "employee" and "agent" shall include the heirs ≱estates, executors, administrators and personal representatives of such persons.
