**ARTICLES OF ORGANIZATION
OF
COST LESS VITAMIN, LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, pursuant to Chapter 608 of the Florida Statutes, hereby makes, acknowledges and files the following Articles of Organization (the "Articles").

ARTICLE I. NAME

The name of the limited liability company is Cost Less Vitamin, LLC (the "Company").

ARTICLE II. MAILING AND STREET ADDRESS

The mailing address and street address of the principal office of the Company shall be 1400 NW 107th Avenue, 5th Floor, Miami, Florida 33172.


ARTICLE IV. DURATION
