The undersigned natural person, who is licensed and otherwise legally authorized to practice law in the State of Florida, for the purpose of forming a limited liability company in accordance with the Professional Service Corporation and Limited Liability Company Act, F.S. Chapter 621, hereby makes, acknowledges and files the following Articles of Organization.

ARTICLE I

Name. The name of the limited liability company shall be DAVID & PHILPOT, P.L. ("Company").

ARTICLE II

Purpose. The purposes for which the Company is formed are:

- a. To engage in the specific business of the practice of law as a professional limited liability company and to carry on services incident thereto. Such practice of law is the sole and exclusive professional service to be rendered by the Company;
- b. To invest its funds in real estate, mortgages, stocks, bonds or any other type of investment;
- c. To engage generally in the business of a law as a professional limited liability company as the same is now or hereafter defined by statute, rule and regulation, and in connection therewith to own real or personal property, to enter into contracts, and to transact any lawful business related thereto;
- d. To engage in such other business incidental to the practice of law as a professional limited liability company as may be authorized or permitted by Florida law;

The professional services of the Company shall be carried out only through its members, officers, employees, and agents, each of whom is duly licensed or otherwise legally qualified to render such professional services in the State of Florida.

ARTICLE III

Address. The mailing address of the principal office of the Company shall be: P.O. Box 940218, Maitland, FL 32794 and street address of the principal office of the Company shall be: 100 E. Faith Terrace, Maitland, FL 32751.

ARTICLE IV

Duration. The Company shall commence its existence on the date these Articles of Organization are filed by the Florida Department of State. The Company's existence shall be perpetual unless the Company is earlier dissolved as provided in the operating agreement of the Company.

ARTICLE V

Initial Registered Office and Agent. The street address of the initial registered office of the Company is 100 E. Faith Terrace, Maitland, FL 32751 and the name of the initial registered agent of the Company at that address is Timothy H. David.

ARTICLE VI

Management. The Company shall be managed by managers in accordance with an operating agreement adopted by the members for the management of the business and affairs of the Company. The operating agreement may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with law or these Articles of Organization. 
