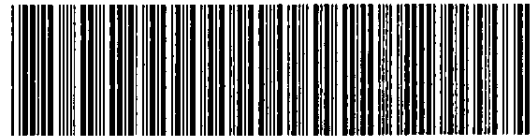


The Sunbiz Detail Page for "98 Real Estate Group, LLC" was updated to reflect the resignation of George Newman one of the two members requesting resignation.


