A Florida Limited Liability Company

- 1. Name. The name of this limited liability company is Community Foundation of Sambel-Captiva, LLC (the "Company"), and it shall be formed as a Florida limited liability company under Chapter 608, Florida Statutes.
- 2. <u>Duration</u>. The Company shall exist from the date of filing of these Articles of Organization with the Florida Secretary of State, and the Company's existence shall be nemetical.

- 9. Voting. The Company is authorized to issue membership units with pringerights and membership units without voting rights.
- 10. <u>Certificated Interests</u>. The members' interests in the Company may be evidenced by certificates.
