ARTICLES OF ORGANIZATION
OF
MG LAND DEVELOPMENT, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, hereby make, acknowledge and file these Articles of Organization.

ARTICLE I - NAME

The name of the Limited Liability Company shall be MG LAND DEVELOPMENT, LLC ("Company").

ARTICLE II - ADDRESS

The mailing address of the principal office shall be 1553 SE Fort King Street, Ocala, FL 34471.

ARTICLE III - DURATION

The Company shall commence its existence on the date these Articles of Organization are filed by the Florida Department of State. The Company's existence shall be perpetual, unless earlier dissolved as provided in the Operating Agreement.

Company shall be managed by its initial member/manager, Nathan Garcia in accordance with the terms and conditions of the Operating Agreement. The Operating Agreement may contain other

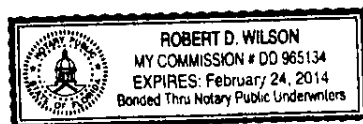

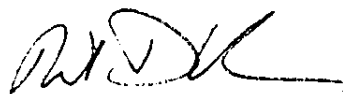
