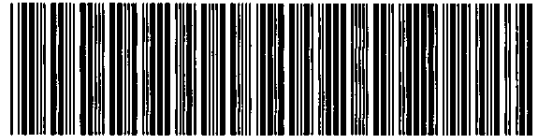


SECOND: The date of the adoption of these Articles of Dissolution is 11 June 2012.
