The name of the limited liability company is: Hillhouse Management Holding, LLC.

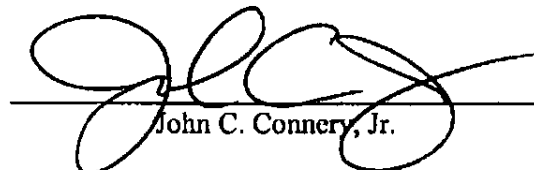
ARTICLE II. ADDRESS

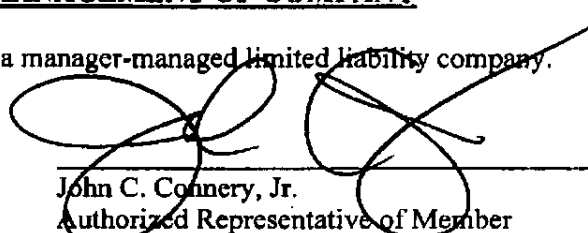
