AMENDMENTS

The Company reserves the right to amend any provision of these Articles of Organization, which amendment shall only be effectuated by the written approval by a majority of the Members of the Company and the approval of the Manager of the Company.

ARTICLE 9

AUTHORIZED REPRESENTATIVE

Under the provisions of the Florida Limited Liability Company Act, Alan J. Rabin, a member of the Company, authorizes Charles D. Hood, Jr., to file these Articles of Organization as an authorized representative of the Company.
