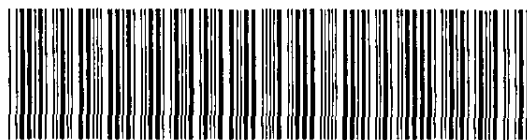

TSC SERVICES, LLC, a limited liability company organized and existing under the laws of the State of Florida (the "Company"), in order to amend its Articles of Organization in accordance with the requirements of Chapter 608, Florida Statutes, does hereby certify as follows:

1. The Articles of Organization of the Company were filed by the Secretary of State of the State of Florida on December 22, 2010.

2. The amendment to the Articles of Organization being effected hereby will completely delete Article VII of the Articles of Organization as of the date hereof, and substitute in its place the Article VII set forth below.

3. This amendment to the Articles of Organization was adopted by the limited liability company.

4. These Articles of Amendment to the Articles of Organization shall be effective immediately upon filing by the Secretary of State of the State of Florida, and thereafter, Article VII of the Articles of Organization of the Company shall read as follows:


**ARTICLE VII
RESTRICTIONS ON MEMBERSHIP**

New members shall be admitted to the limited liability company upon approval by the Board of Managers in accordance with any approval procedure or limitation set forth in the Operating Agreement. Contributions required of a new member shall be determined by the Board of Managers as of the time of the admission of the new member to the limited liability company. A member's interest in the limited liability company may not

be sold or otherwise transferred except in accordance with the Operating Agreement of the limited liability company.

IN WITNESS WHEREOF, TSC Services, LLC has caused these Articles of Amendment to the Articles of Organization to be executed this 1st day of January, 2010.
