**ARTICLE 1
NAME**

The name of this limited liability company is Maricamp-Pine Investors, LLC.

**ARTICLE 2
PERIOD OF DURATION**

The period of duration of this limited liability company is perpetual. The effective date of these articles is the date of filing with the Florida Department of State. Pursuant to the provisions of Section 608.439(4), Florida Statutes, the existence of this limited liability company shall be deemed to have commenced on July 1, 1996, the date that Maricamp-Pine Investors, Inc., the corporation being converted into this limited liability company, commenced its existence.

**ARTICLE 3
PURPOSE**

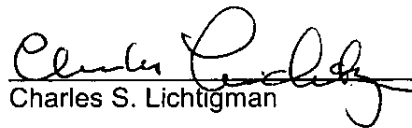
