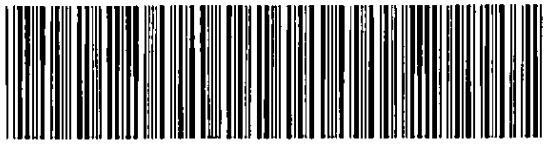


The name of the Company is STRATA CONSULTING, LLC, a Florida limited liability company.
