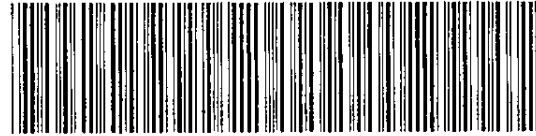

Address of Registered Office, Registered Agent and Principal Office


