ARTICLES OF AMENDMENT TO ARTICLES OF ORGANIZATION

FOR

SZ & SZ AMERICA, LLC [Document Number L10000134400]

Sz & Sz America, LLC, a Florida limited liability company (the "Company"), in order to amend its Articles of Organization, does hereby submit the following:

- 1. The name of the Company, as set forth in the Articles of Organization, is currently Sz & Sz America, LLC. The purpose of this amendment is to change the name of the Company to Cake Factory, LLC.
- 2. The Company's Articles of Organization were filed on December 23, 2010, with the Florida Secretary of State and assigned Florida document number L10000131400.
- 3: Article I of the Company's Articles of Organization is hereby amended by deleting it in its entirety and substituting in its place the following provision:

Article J - Name

The name of this limited liability company is: Cake Factory, LLC.

4. The foregoing amendment to the Company's Articles of Organization was approved and adopted by all of the members, which is the only group entitled to vote on the amendment, by written consent in licu of meeting, effective September 25, 2014.

Except as amended above, the Articles of Organization shall remain as they were prior to this amendment being adopted.
