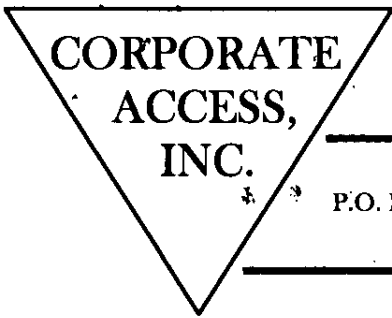

**THIRD:** The mailing address and street address of the principal office of the Limited Liability Company is 8130 Lake Serene Drive, Orlando, FL 32836.


