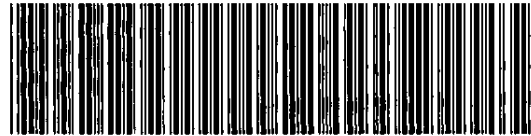

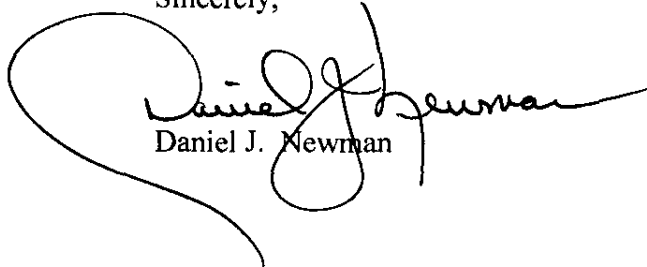

I, the undersigned, certify that I hereby organize for the purpose of becoming a Limited Liability Company under the laws of the State of Florida, providing for the formation, rights, privileges, and immunities of a Limited Liability Company. I further declare that the following Articles shall serve as the Articles of Organization and authority for the conduct of business of a Limited Liability Company (the "Company").

**ARTICLE I
Name**

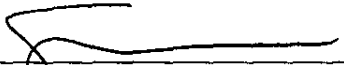
