**ARTICLES OF ORGANIZATION***of***T.H. DAVIS FAMILY FARM, LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes, Chapter 608, hereby makes, acknowledges and files the following Articles of Organization.

**ARTICLE I****NAME AND ADDRESS**

The name of the limited liability company shall be T.H. Davis Family Farm, LLC (the "**Company**"). The mailing and street address of the principal office of the Company in Florida shall be 28163 Dog Gone Trail, Hilliard, Florida 32046.

**ARTICLE II****PURPOSES AND POWERS**

The general purpose for which this Company is organized is to transact any lawful business for which a limited liability company may be organized under the laws of the State of Florida.
