**ARTICLES OF ORGANIZATION
OF

The undersigned authorized representative executes these Articles of Organization to form a limited liability company under the Florida Limited Liability Company Act:

ARTICLE I. NAME

The name of the limited liability company is Beckel Charitable Enterprises, LLC.

ARTICLE IV. MANAGEMENT OF COMPANY

The business of the limited liability company will be managed by one manager who will be elected or appointed by the members of the limited liability company in the manner set forth in its Operating Agreement. The name of the initial manager is Jacob J. Beckel. If Jacob J. Beckel is unable or unwilling to serve as the sole manager of the limited liability company, Mary F. Beckel will serve as the successor manager.

The manager has the power and authority, to the exclusion of the members, to manage the affairs and business of the limited liability company and will hold the office and have the responsibilities that are conferred on the manager in the Operating Agreement of the limited liability company. A member of the limited liability company does not have any authority to incur any contractual liability or obligation on behalf of the limited liability company, unless the member is also the sole manager of the limited liability company.

ARTICLE V. PURPOSE, POWERS, AND AUTHORITY

The limited liability company is organized for any lawful purpose, except banking and insurance. In furtherance of its purpose, the limited liability company has full power and authority to do all acts and things authorized by law to carry out its affairs and business, including without limitation the power and authority to do everything described in the Florida Limited Liability Company Act.

ARTICLE VI. COMMENCEMENT OF EXISTENCE

The existence of the limited liability company will commence at 12:01 a.m. on December 28, 2010, when these Articles of Organization are filed by the Florida Department of State.



ARTICLES OF ORGANIZATION AND OPERATING AGREEMENT**


