Padron as an Authorized Member, as reflected in the July 13, 2017 Articles of Amendment to Articles of Organization of the Company, was made without the Company's knowledge or consent. The Company is not, and never was, affiliated in any way with Lazaro R. Padron and he does not, and did not, have the authority to act on the Company's behalf.
- 5. The amendment to remove Israel Kopel as an Authorized Member, as reflected in the July 13, 2017 Articles of Amendment to Articles of Organization of the Company, was made without the Company's knowledge or consent. Neither the Company nor the undersigned authorized this change.
- 6. The signature of Israel Kopel in the July 13, 2017, Articles of Amendment to Articles of Organization of the Company was forged and was made without Israel Kopel's knowledge, approval, or consent.
- 7. The filing of the July 13, 2017 Articles of Amendment to Articles of Organization constitutes a false, fictitious, or fraudulent statement in a matter within the jurisdiction of the Department as described in Section 817.155, Florida Statutes.
